Managing the Under-Recovery of F&A

Presenters: Mark Daniel, Attain LLC and Vivian Holmes, Boston University

Description: With reductions expected from federal research sponsors, institutions are increasingly under pressure to grow their non-federal portfolios, including funding from philanthropic foundations. Many of these sponsors do not allow for reimbursement of F&A or in some case only cover a small portion. In addition, many have made changes to their administrative requirements and policies adding specific compliance requirements as well as unique application and reporting templates and procedures, all of which are further burdening central and departmental administration.

Level: All

Prerequisite: Participants should have an understanding of budgeting and an appreciation of the impact of facilities and administrative expenses within our institutions.

Learning Objectives: Participants will discuss the primary issues and impact of reduced overhead, acquire tools to track and monitor its value, and develop strategies for mitigating under-recovery of facilities and administrative costs.

Current and Pending Support/Other Support: What Are We Reporting, and Why?

Description: Grant applications to federal sponsors require institutions to disclose information for key personnel on active and pending awards. This information must be submitted at the time of proposal, or "just-in-time," and is referred to as "current and pending support" (NSF and other agencies) or "other Support" NIH. The information includes all financial support and resources available in direct support of an individual's research endeavors, and effort committed to the project. The presenters will describe the NSF and NIH reporting requirements and facilitate a discussion about challenges institutions encounter in meeting the reporting requirements and what can be done to ensure the accurate of current and pending support.

Prerequisite: Participants should be familiar with the reporting requirements of federal agencies for "current and pending support" and "other support" for ongoing projects and proposals



Learning Objectives: Participants will gain an understanding of the agency requirements governing current and pending support/other support, identify challenges institutions face in meeting the reporting requirements, and share information on how to improve the accuracy of reporting.
