- PAPPG change to clarify "Current & Pending Support" requirements

Science & Security - NIH



NIH

- Disclosure and peer review issues
- ACD report 13 Dec 2018 with recommendations
- Potential violations communicated by OER
 - ➤ 66 institutions, 150+ researchers, 16+ cases referred to HHS OIG
 - Researchers dismissed from 2 institutions, resigning from others

Purpose

The intent of this notice is to remind the extramural community about the need to report foreign activities through documentation of other support, foreign components, and financial conflict of interest to prevent scientific, budgetary, or commitment overlap. NIH has long required full transparency for all research activities both domestic and foreign and does not consider these clarifications to be changes in policy. The requirements referenced in this Notice, along with the other obligations in the NIH Grants Policy Statement (NIHGPS) and other terms and conditions of award, are instrumental to achieving the mutual goal of NIH and the extramural community, to protect the integrity of biomedical research.

Science & Security - Commerce



- Commerce/BIS 11/18 ANPRM (Advanced Notice on Proposed Rule Making), on Controls for Emerging Technologies
- Subsequent proposed rule(s) expected shortly
- Also ANPRM on Foundational Technologies

Science & Security – Dept of Educ



- > HEA Section 117 reporting requirement
- Requirements not clear
 - ➤ Higher Ed Assoc letters Jan 18, June 21, July 12, July 30
- Multiple universities have been asked for additional information – focus is broader than one country

Science & Security – Congress



Bipartisan Issue

- <u>Inquiries</u> to federal agencies regarding actions to date (e.g. Sen. Grassley DOD, NIH, NSF, DOJ, HHS, etc.)
- <u>Transparency</u> (e.g. Rep. Gosar on agreements between institutions and foreign source; financial reporting disclosure)
- Export controls (e.g. foreign nationals on campus and deemed exports)
- Confucius Institutes (e.g. restricts eligibility for funding and/or requires registration)
- <u>Restrictions on companies/technology</u> (e.g. Huawei, ZTE; expansion of controls for "sensitive research projects")
- New coordination efforts and/or offices/subcommittees (e.g. SASTA, Office of Critical Technologies and Security)
- Government reporting (e.g. list of sensitive research subjects and/or statesponsored or controlled organizations; coordination between DOD and universities)
- <u>Training</u> (e.g. students studying abroad; foreign language funding)
