Radio Frequency Identification (RFID) and Inventory Management

Description: Responsible stewardship of an institution's physical assets is a complex challenge. **Physical inventories at least every two years are required** for assets purchased on federal funds [2 CFR 200.313 (d)(2.)] and for non-federal equipment for which depreciation is claimed in an F&A proposal [2 CFR 200.436 (d)]. Accurate locations for research equipment are fundamental to maximizing F&A recovery, and meeting the requirement for a physical inventory can pose a substantial burden on lab staff and administrators. This session will cover the advantages of RFID technology and will describe actual implementations. Harvard will discuss its decision to move to RFID, its detailed vendor selection, and its incremental implementation experience. Industry leaders will share insights from other implementations, describe the current state of the technology, and reinforce the importance of asset management to F&A recovery and stewardship of federal funds. The session will include a live demonstration of RFID technology.
