The **Director of Communications and Development** will be a member of the executive team and in collaboration with the Executive Director will be responsible for the Institute's communications and fundraising strategies and implementation, including securing and maintaining public and private funding through grant proposals and renewals. The Director will supervise two staff and manage relevant consultants.

The ideal candidate is skilled at storytelling and will lead the development of a shared compelling narrative about our work and generate interest and support from colleagues, funders, elected officials and the press.
