- Work with the Communications team to create a program wide communications plan.
- Work with the Communications team to remove workflow bottlenecks, and help plan and organize project plans to meet program deadlines for content creation.

- Update, file, and organize all existing Branded material in Basecamp, and shared drives, as needed.
