- Lead large-scale professional learning facilitation for professional development providers, educational leaders, teachers and family child care network staff.
- Provide targeted developmental screening and assessment support across the five boroughs (in person or virtual)

Data Tracking and Communications

- Submit a log documenting each visit in a timely manner.
- Review and analyze survey data to inform ongoing practice.
- Provide outreach to programs regarding DECE developmental screening and assessment policies.
