## **General Description**

#### About us

The CUNY Institute for State and Local Governance has a mission to improve the financing, delivery, and measurement of critical public services through research, technical assistance, and education. We lead projects aimed at reforming the criminal justice system, measuring urban inequality, expanding the reach of social service providers, and more. Each project has a dedicated team of research and policy experts who collaborate closely with internal and external organizations. Our staff have the opportunity to work with colleagues and supervisors across projects and with different types of expertise. We are seeking new team members with enthusiasm to shape the future of state and local policy.

### Our goals for diversity and inclusion

We strive to foster an office environment and an approach to work that welcomes and respects different perspectives, backgrounds, and life experiences. #### Who we are looking for

We are hiring a Research Project Director to oversee and manage a substantial portfolio of research and evaluation work related to the implementation of New York City's police reform agenda ("NYC Police Reform and Reinvention Collaborative Draft Plan: Parts 1 & 2"). The agenda is centered on "envisioning an NYPD that is the nation's exemplar institution for fair, just, transparent, and accountable policing regardless of race, gender, ethnicity, sexual orientation, religion, immigration or socioeconomic status." Among the specific initiatives in this portfolio are process and outcome evaluations of three New York Police Department (NYPD) initiatives that are included in the plan, and the development and implementation of performance frameworks for measuring progress on the full set of initiatives and police reform more broadly. The Research Project Director will be responsible for managing all aspects of the projects in the portfolio, including strategizing, supervising staff, keeping the work on task and timeline, and ensuring the quality of the work. The Research Project Director will also be responsible for elevating issues—as needed—to the Research Director, who will provide broad oversight and strategic support to the project; and for ensuring close collaboration with a policy team that is advancing a complementary portfolio of technical assistance work on a number of the same initiatives in the plan.

This is an excellent opportunity for a civic-minded professional interested in working in a public policy setting, and for a range of audiences that include government officials, community providers, funders, researchers, and the general public. This is also an excellent opportunity to develop an understanding of government policymaking in New York City and nationally, in a number of areas including criminal justice, racial equity, government operations and community development.

The Research Project Director will be responsible for a range of tasks, which *may* include but are not limited to:

- Developing and operationalizing research and methodological plans and adapting them throughout the course of the work as needed
- Overseeing qualitative and quantitative research activities that include interviews, focus groups, performance monitoring, and survey work
- Strategizing and problem-solving issues that arise and thinking critically about all aspects of project work, including when course changes are needed to meet the overall goals
- Supervising a team of five to seven staff in their day-to-day project-related tasks
- Creating and managing workplans and ensuring that the work stays on task and timeline
- Establishing workflow processes and expectations for internal and external elements of the work
- Managing the budget for the portfolio of projects
- Ensuring the integrity of all deliverables
- Building and managing day-to-day relationships with government and community partners on the initiative
- Representing ISLG at external meetings and events and facilitating meetings with staff and/or external stakeholders as needed
- Overseeing the development of research reports, briefs, memos and other written deliverables
- Presenting to various stakeholder audiences, including government and community members
- Working closely with the Research Director on high-level strategic questions and in liaising with the Mayor's Office, NYPD, and other government partners
- Working closely with the Research Director and other ISLG Senior Leadership to contribute to project development and strategy for the Institute overall

Our office is located in New York City and the position will be housed there over the long-term, however, work will be **remote through the immediate term**.
