## **General Description**

#### **Position Description**

Reporting to the Senior Policy Associate, the Policy Analyst will be responsible for supporting a body of work in the following three public finance areas: i) budget and fiscal analysis, ii) cost-benefit analysis, and iii) economic analysis. The analyst's key responsibilities will include: analyzing budget, fiscal, revenue, and agency-specific strategies to help governments increase productivity and efficiency; identifying revenue and cost effective policies and strategies; and identifying budget relief for critical activities. The analyst will provide technical guidance on budgets and fiscal policy, detailed analysis of operating and capital budgets, and development of systems for tracking and monitoring budget allocations, expenditures, grants and contracts.

The analyst will also develop a skill set for cost-benefit analysis by supporting the senior policy associate on current projects within the Institute, including analysis on quantitative and qualitative data to determine the economic costs and benefits of government programs, policies, interventions, and other activities.
