### Cycle 57

- September 15, 2025 Grants Proposal System opens for application submissions.
- December 15, 2025, 11:59 PM EST Application submission deadline for Cycle 57 Track 1 and Track 2 Awards. Your college may have an earlier internal deadline.
- May 15, 2026 Notification of Cycle 57 Awards sent to faculty who applied for Track 1 and Track 2 Awards.
- July 1, 2026 Cycle 57 Track 1 and Track 2 Awards begin.
- June 30, 2027 Cycle 57 Awards terminate. Requests to exercise the six-month extension must be received by this date.
- September 30, 2027 All receipts for expenditures must be received by the Research Foundation for grants that terminate June 30, 2027.
- December 31, 2027 Extended Track 1 and Track 2 Awards terminate.
- March 1, 2028 Final reports due for Cycle 57 awards.
- March 31, 2028 All receipts for expenditures must be received by this date for grants that terminate on December 31, 2027.

- September 15, 2024 Grants Proposal System opens for application submissions.
- December 16, 2024, 11:59 PM EST Application submission deadline for Cycle 56 Traditional A, Traditional B and Enhanced Awards. Your college may have an earlier internal deadline.
- April 15, 2025 Notification of Cycle 56 Awards sent to faculty who applied for Traditional A or Traditional B Awards.
- May 15, 2025 Notification of Cycle 56 Awards sent to faculty who applied for Enhanced Awards.
- July 1, 2025 Cycle 56 Traditional A, Traditional B and Enhanced Awards begin.
- June 30, 2026 Cycle 56 Awards terminate. Requests to exercise the six-month extension must be received by this date.
- September 30, 2026 All receipts for expenditures must be received by the Research Foundation for grants that terminate June 30, 2026.
- December 31, 2026 Extended Traditional A, Traditional B and Enhanced Awards terminate.
- March 1, 2027 Final reports due for Cycle 56 awards.
- March 31, 2027 All receipts for expenditures must be received by this date for grants that terminate on December 31, 2026.

- July 1, 2024 Cycle 55 Traditional A, Traditional B and Enhanced Awards begin.
- June 30, 2025 Cycle 55 Awards terminate. Requests to exercise the six-month extension must be received by this date.
- September 30, 2025 All receipts for expenditures must be received by the Research Foundation for grants that terminate June 30, 2025.
